## Fuel Surcharge Mechanism

Fuel surcharge is adjusted on the 1<sup>st</sup> of each month based on the current published UK Government Weekly Road Fuel Prices for the respective week.

### Fuel Surcharge calculation methodology\*

Calculation of the fuel surcharge is based on two main factors, the invoice subtotal before VAT and the current price per litre of fuel.

Based on the price per litre of fuel, a fuel surcharge percentage is applied to your invoice subtotal before VAT.
